2. HAZARDS IDENTIFICATION

Main hazards: Extremely flammable. Irritating to skin. Harmful: danger of serious damage to health by prolonged exposure through inhalation. Possible risk of harm to the unborn child. Vapours may cause drowsiness and dizziness.

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be irritation and redness at the site of contact.

Eye contact: There may be irritation and pain. The vision may become blurred.

Ingestion: There may be soreness and redness of the mouth and throat. There may be vomiting. Inhalation of fumes from the stomach may cause symptoms similar to direct inhalation.

Inhalation: There may be a feeling of tightness in the chest with shortness of breath. Exposure may cause coughing or wheezing. Drowsiness or mental confusion may occur. There may be congestion of the lungs causing severe shortness of breath.

4. FIRST AID MEASURES (ACTION)

- Skin contact:** Wash immediately with plenty of soap and water. Remove all contaminated clothes and footwear immediately unless stuck to skin. Consult a doctor.
- Eye contact:** Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination.
- Ingestion:** Do not induce vomiting. Wash out mouth with water. If conscious, give half a litre of water to drink immediately. Transfer to hospital as soon as possible.
- Inhalation:** Remove casualty from exposure ensuring one's own safety whilst doing so. If conscious, ensure the casualty sits or lies down. If unconscious, check for breathing and apply artificial respiration if necessary. Transfer to hospital as soon as possible.

5. FIRE-FIGHTING MEASURES

- Extinguishing media:** Water spray. Carbon dioxide. Dry chemical powder. Alcohol resistant foam. Use water spray to cool containers.
- Exposure hazards:** Extremely flammable. Harmful. Vapour may travel considerable distance to source of ignition and flash back. Forms explosive air-vapour mixture.
- Protection of fire-fighters:** Wear self-contained breathing apparatus.

6. ACCIDENTAL RELEASE MEASURES

- Personal precautions:** Do not attempt to take action without suitable protective clothing - see section 8 of SDS. Eliminate all sources of ignition. Turn leaking containers leak-side up to prevent the escape of liquid.
- Environmental precautions:** Do not discharge into drains or rivers. Contain the spillage using bunding.
- Clean-up procedures:** Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate method.

7. HANDLING AND STORAGE

- Handling requirements:** Ensure there is sufficient ventilation of the area. Smoking is forbidden.
- Storage conditions:** Store in cool, well ventilated area. Keep away from sources of ignition.
- Suitable packaging:** Must only be kept in original packaging.
