### 2. HAZARDS IDENTIFICATION

**Main hazards:** May cause sensitisation by skin contact.

### 3. COMPOSITION / INFORMATION ON INGREDIENTS

**Hazardous ingredients:** ACTICIDE PASTE 1-10%  
[Xn] R48/22; [Sens.] R43; [Xn] R68

### 4. FIRST AID MEASURES (SYMPTOMS)

**Skin contact:** There may be mild irritation at the site of contact.  
**Eye contact:** There may be irritation and redness.  
**Ingestion:** There may be irritation of the throat.  
**Inhalation:** There may be irritation of the throat with a feeling of tightness in the chest.

### 4. FIRST AID MEASURES (ACTION)
